

## SRVUSD “SAFE SCHOOLS” TRAINING PREVIOUSLY CONDUCTED

In February, 1999, the San Ramon Valley Unified School District conducted a day-long “Safe Schools” training program for school counselors. Handout materials indicate that the program was less about tolerance than it was about desensitization and homosexual advocacy.

A page allegedly clarifying “**Legal Concerns Pertaining to Sexual Orientation and Gender Identity Issues**,” for example, ignored California Penal Code § 286, which defines sodomy involving unmarried minor children as a felony. The same page recast Education Code sections calling for “social sciences” in grades 1-12 as a mandate to discuss “same sex marriage, gays in the military, the gay civil rights movement, and family diversity” at all grade levels — and all in the name of “promoting safe schools.”

A three-page “**Definition of terms**,” relying on such sources as the “Campaign to End Homophobia” and a “Sex Information Education Council of the US” (SIECUS) report on “Sexual Orientation Education and Homophobia Reduction Training,” identified “Inclusive Language” as “the use of gender non-specific language (i.e. ‘partner’ instead of ‘husband’)...,” and “Coming Out ‘of the closet’” as “the never-ending process of becoming aware of one’s sexual orientation, accepting it, acting on it, and telling others about it....”

A so-called “**FactFile**” on “**Lesbian, Gay, and Bisexual Youth**” cited thoroughly discredited misinformation (e.g., “10% are predominantly homosexual”) from Alfred Kinsey, whose lies, facilitation of criminal child molestation, and other perversions have been exposed in *Kinsey, Sex and Fraud* (Dr. Judith Reisman, 1990) and other books. Additional “Fact File” fallacies included a junk-science claim that “up to 30% of completed youth suicides are committed by lesbian and gay youths annually.” That assertion appeared in a 1989 report that was immediately repudiated as biased and inaccurate by its recipient, Dr. Louis Sullivan, then Secretary of Health and Human Services. More reliable studies in 1959, 1986, and 1993 found that homosexuality accounts for perhaps 2.7% of teen suicides — at most.

Under “**Guidelines for Answering Sensitive Questions**,” the handout pages advised how to handle students who ask things like “So, just what do fags do in bed anyway?” Instead of denouncing K-12 curricula which motivate such questions as entirely inappropriate, indeed counterproductive, the CCEB guide suggested that teachers might answer, “Gay, lesbian, and bisexual people express affection the same way that anyone else might” [though such common homosexual practices as sodomy, “fi\_\_g,” “r\_\_\_\_g,” “s\_t,” and “g\_\_\_\_n showers” are hardly the way “anyone else” might “express affection”].

Attendees at CCEB’s San Ramon session were further indoctrinated with a viewing of *It’s Elementary: Talking about Gay Issues in School*, a film which records and blatantly advocates pro-homosexual de-sensitizing of children at even the lowest grade levels. The American Family Association (601-844-5036, [www.afa.net](http://www.afa.net)) has condemned *It’s Elementary* for its depiction of “adults — including parents — as the wellspring of ignorance, bigotry and homophobia,” with Christianity receiving “especially venomous treatment in the video.” According to Tammy Bruce, quoting Brent Bozell of the Media Research Center, the **song heard over the closing credits says, in part, ‘Your children are not your children.... [T]hough they are with you, [T]hey belong not to you.’”**
